1. Contestants shall be female, of Chinese descent, a Canadian Citizen or Landed Immigrant and a resident of Alberta for a minimum of six (6) months prior to June 21, 2003.
2. Contestants shall be single (never been married and never had children), between the ages of seventeen (17) before June 21, 2003; and twenty-five (25) before December 31, 2003.
3. Contestants shall be available for all training sessions, rehearsals and other scheduled activities between July 1, 2003 and September 30, 2003.

4. Contestants shall complete, sign and forward this official application, along with one (1) recent photo to the address below.
5. Contestants are required to commit exclusively to the 2003 Miss Calgary Chinese Pageant. Participation in any other competitions of similar nature is not permitted, unless with the 2003 Miss Calgary Chinese Pageant Committee's written consent.
6. No application fees are required.
7. All applications are subject to the approval of the 2003 Miss Calgary Chinese Pageant Committee.
8. All applications shall be held in strictest confidence and shall become property of the 2003 Miss Calgary Chinese Pageant Committee.
